

Sir,

In producing here with one arrested accd namely Bimal Majhi (22Y) S/O Hapan Majhi of Vill Parkidih, PS- Arsha, Dist- Purulia along with following seized articles viz –

1) One Yellow colour plastic container with approx 18 ltrs of cholai,

(Approx 375 ml taken out from each of the above containers as sample packed with sealing wax)

I, ASI Ujjal Rajak of Arsha PS do hereby lodge a written complaint against the above noted accused person to the effect that today 09.01.2020 at about 16:45 during my special mobile duty receive source information over telephone that the above noted accused has been selling liquor illegally and clandestinely in his house at Parkidih village under Arsha PS, Dist- Purulia. On receiving the reliable source information I communicated with O/C Arsha PS over telephone and as per his instruction I along with C/- 129 Haripada Rajwar of Arsha PS and C/- 626 Buddhadeb Murmu of SAP 7th Bn camp at Arsha PS rushed to the spot to work out the information. Reaching at Parkidih village at 17:15 hrs we fixed-up the house of above noted accd. person and noticed that the selling country spirit was going on there and getting seen of police all customers were managed to escape, but we able to apprehended the above noted accused person. On demand of papers he failed to produce any valid documents in support of selling Cholai. So I seized the entire implicating article as noted above under a proper seizure list from his exclusive possession in presence of witnesses and properly sealed and labelled duly signed by the accused person and witnesses among which Approx 375 ml taken out from the above container as sample packed with sealing wax with label. During interrogation he confessed his guilt so, I arrested him after observing all the formalities issuing memo of arrest as the accused persons are liable for prosecution u/s 46A(c) of The Bengal Excise Act, 1909.

I therefore pray that a specific case may kindly be started against the accused namely Bimal Majhi (22Y) S/O Hapan Majhi of Vill Parkidih, PS- Arsha, Dist- Purulia U/S 46A(c) The Bengal Excise Act, 1909, and arrange its regular investigation.
