In producing herewith the accused person namely Sitaram Mura (45 Years) S/O Late- Bhudal Mura of Vill- Dugdha, P.S- Baghmundi, Dist- Purulia along with seized articles 1) 10 (Ten) ltr I.D liquor in a white colour plastic Jerican, 2) 08 (Eight) ltr I.D liquor in a white colour plastic Jerican, 3) One sample plastic bottle (600 ML) from 18 ltrs of 02 Jericans, 4) Empty Plastic Glass- 10 Pcs. 5) Cash Rs. 115/- (One Hundred Fifteen) as sale proceed which were seized under proper seizure list duly signed by the witness.

I beg to submit that today on 28.01.2020 during my special raid duty as per source information I along with 1.JC/227 Bidyut Mandal, JC/740 Subhendu Satpati both of Suisa OP under Baghmundi P.S reached at Dugdha village at 17.15 hrs and found that the above noted person is selling I.D liquor at his dwelling house under Baghmundi P.S, Dist Purulia. On demand he failed to produce any valid document from competent authority in respect of stocking & selling of I.D liquor. As such he was arrested U/S- 67 B.E. Act and also seized in his possession 1) 10 (Ten) ltr I.D liquor in a white colour plastic Jerican, 2) 08 (Eight) ltr I.D liquor in a white colour plastic Jerican, 3) One sample plastic bottle (600 ML) from 18 ltrs of 02 Jericans, 4) Empty Plastic Glass- 10 Pcs. 5) Cash Rs. 115/- (One Hundred Fifteen) as sale proceed, which were seized under proper seizure list duly signed by the witnesses U/S- 67 B.E. Act. A sample ID liquor taken out as sample and all seized articles were labeled properly in presences of witness and accused person. Hence I arrested the above noted person at 17.25 hrs. During arrest I maintain all formality of arrest rule. I offered him medical treatment but he deny.

The above noted arrested accused person namely Sitaram Mura (45 Years) S/O Late- Bhudal Mura of Vill- Dugda, P.S- Baghmundi, Dist- Purulia committed an offence U/S-46 A(c) B.E. Act. 1909 for unauthorized possession and selling of Id Liquor from his sole possession.
