Kalipada Lays of village EKrs, P.O- EKrs PS- Bagmundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 02/01/2020 at about 1:25 P.M I Sri Swapan Kumar Das, AE & Station Manager, Baghmundi CCC along with 1. Sri Sajal Kumar Mahanta, OS 2. Abdul Hasib, LM, entered the premises of Sri Gagan Lays, S/O- Lt. Kalipada Lays of village EKrs, P.O- EKrs, Dist- Purulia and found Sri Gagan Lays was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.1 KVA. As Sri Gagan Lays S/O- Sri Lt. Kalipada Lays committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Sajal Kumar Mahanta, OS, WBSEDCL 2. Sri Abdul Hasib, LM, WBSEDCL. The inspection team left the premises at 1:35 P.M. 02/01/2020.
