Sir,

In producing herewith arrested accused person namely Paban Chandra Paramanik (42 Yrs), S/O- Jitu Paramanik of vill- Dava, PS- Balarampur, Dist Purulia along with seized articles,

I beg to report that on 09.01.2020 in between 06:00 hrs to 06:20 hrs in course of Mobile Duty I SI Sudhir Kumar Mahato of Bagmundi PS received telephonic information from my source over telephone that Paban Chandra Paramanik (42 Yrs), S/O- Jitu Paramanik of vill- Dava, PS- Balarampur, Dist Purulia a huge numbers of wine bottles are staged in an open field at Bansitar village (Salban) under Baghmundi PS. The above noted person is selling country-sprit in the open field at Bansitar village (Salban) under Baghmundi PS, accordingly I informed to my O/C Baghmundi PS in this regard. As per direction of O/C Baghmundi PS myself along with force reached in the open field at Bansitar village (Salban) under Baghmundi PS to work out the information. Myself along with force reached the spot and held raid and found that the some persons were assembled and consuming liquor in the open field at Bansitar village (Salban) under Baghmundi PS.

On seeing police party the assembled persons managed to flee away from the spot. On search there and found that the said person has selling the country spirit in in the open field at Bansitar village (Salban) under Baghmundi PS. On demand he failed to produce any valid papers/ documents in support of selling country spirit in the open field at Bansitar village (Salban) under Baghmundi PS and I seized 1) 15 (Fifteen) sealed bottle country made, name and style as "DIL SE" containing 600 ml of each bottle, 2) 05 pcs empty glass 3) One sample bottle (600 ML) of "DIL SE" out of 15 bottle 4) Cash Rs. 105/- (One hundred and five only) as sale proceed, from the possession of above noted person under proper seizer list duly signed by him and witnesses also prepared label. Accordingly I arrested him after maintaining all arrest rules as well as guideline of NHRC.

Therefore I pray before you that kindly arrange to start a specific case as per law against arrested accused person Paban Chandra Paramanik (42 Yrs), S/O- Jitu Paramanik of vill- Dava, PS- Balarampur, Dist Purulia and arrange for its investigation.
