Sir,

In producing here with the accused person Ramu Routh (48 yrs) S/O- Bindu Routh of Vill.- Balarampur Registrypara, P.S.- Balarampur, Dist.- Purulia and brought under seizure 08 (eight) packets of Rice containing 50 kg in each packet and one Toto orange & blue colour.

I SI Satrughna Mahato of Balarampur PS do hereby lodge a complaint as suomoto against Ramu Routh (48 yrs) S/O- Bindu Routh of Vill.- Balarampur Registrypara, P.S.- Balarampur, Dist.- Purulia to the effect that today on (06.01.2020) at about 14:15 hrs when I was performing evening Naka duty at NH-32 near Berma Check Post, I intercepted one Toto (orange & blue colour) without any number loaded with 08 (eight) packets of Rice containing 50 KG in each packet. On being asked the driver of the Toto disclosed his identity as Ramu Routh (48 yrs) S/O- Bindu Routh of Vill.- Balarampur Registrypara, P.S.- Balarampur, Dist.- Purulia but the above noted person failed to produce any valid documents in respect of 08 (eight) packets of Rice, rather, he stated different statement on different times in respect of such possession of the rice, hence, there is every reason to believe that the above noted person has possessed the said rice by adopting any fraudulent means, on further interrogation, he confessed that he procured the approx 04 quintals (50 X 08 Packets) of rice dishonestly and was about to sale the rice clandestinely for his wrongful profit. Accordingly, I seized 08 (eight) packets of Rice containing 50 kg in each packet and one Toto orange & blue colour under proper seizure list duly signed by the witnesses and arrested the accused person Ramu Routh (48 yrs) S/O- Bindu Routh of Vill.- Balarampur Registrypara, P.S.- Balarampur, Dist.- Purulia after observing all formalities regarding arrest.

Under the above circumstances, and fact, I therefore pray that a cog case may kindly be started U/S-379/411 IPC against Ramu Routh (48 yrs) S/O- Bindu Routh of Vill.- Balarampur Registrypara, P.S.- Balarampur, Dist.- Purulia and arrange for its investigation.
