I, SI Satrughna Mahato of Balarampur PS do hereby lodged written complaint as suomoto against 1) Rehan Hasmi @ Usman Gani (29 yrs) S/O- Kalim Aktar of House No-17 Road No-10, Baccha Khan road, Zakirnagar East, Near Reliance Academy, House No-17, PS-Azadnagar, Dist-East Singhbhum (Jamshedpur) 2) Md. Alam @ Alam Ansari @ Gawala (32 yrs) S/O-Nabi Hussion Ansary of Kabir Nagar Kopali Link road, near Ali Akbar Polyclinic, PS-Chandil, Dist- Saraikela Kharswan 3) Salman Hasmi @ Lala (23 yrs) S/O- Asif Khan of Road No -10, Jakir Nagar Mango, Holding No-40, PS -Azadnagar, Dist- East Singhbhum A/P Cross road No-10, Zakirnagar PO-Azadnagar, PS- Ajadnagar Dist- East Singhbhum, Home town Aman place 4) Md. Saddam Alam (26 yrs) S/O- Md Amin of Sahi Bagan Road-7, House No-7, PS- Azadnagar, Dist-East Singhbhum

On 15.01.2020 at 00:15 hrs during my night patrolling duty vide Balarampur PS C.C No.-214/2020 dated-14.01.2020 and GDE No-677 Dated-14.01.2020 received a credible source information that 5/6 miscreants are assembling and preparing to commit Dacoity at Balarampur Rangadih area under Balarampur PS area. I informed O/C Balarampur PS and as per order of O/C Balarampur PS myself along with another night patrolling officer and force namely 1) ASI Mukti Nath Chakraborty 2) C/838 Rakhal Ch. Mahato 3) C/159 Swapan Kr. Deoghoria 4) C/18 Gurudas Manato 5) JC/1208 Prabhat Chalak 6) JC/1056 Prasanta Roy 7) JC/286 Dipak Pradhan of Balarampur PS wearing full uniform left for Rangadih under Balarampur P.S. to work out the information. On reaching near Rangadih railway x-ing, we stopped our vehicle at a distant place as guided by the source and proceeded towards the anticipatory place and we noticed that some persons were sitting/ assembled surrounding each other in the dark side of Bidhan colony. We silently proceeded nearer to them and heard that they were planning in between each and other for committing Dacoity in a house of Rangadih Bidhan colony. Accordingly, we cordoned them and I shouted in a loud voice disclosing our identity and asked them to surrender before us. In the mean time, the assembled miscreants tried to flee away from the spot but we managed to apprehend above noted four miscreants and two persons managed to escape despite hot chase which was seen by dragon light those were with us. On being asked, they failed to give any satisfactory reply in respect of their presence at there in such dead hours of late night. In course of thorough interrogation they disclosed their particulars as noted above. In course of searching individually, I found the following articles from them

- 1) one 'country made improvised PISTOL (Total length approx 17cm) having 7.65MM bore, Magazine (Length approx 9.5 cm), Trigger, Butt measuring approx 8 cm and one Golden Colour Vivo 1610 Mobile Phone having IMEI No.- 865207032766615 & 865207032766607 with Sim No.- 9065614809 from the waist of accused Rehan Hasmi @ Usman Gani S/O- Kalim Aktar.
- 2) One knife length about 35 cm. consisting a wooden Butt and one Black Colour Infocus Keypad Mobile Phone having IMEI No.- 957830086883492 & 357830081883497 with a Sim Card No.- 9771341738 from the waist of Salman Hasmi @ Lala S/O- Asif Khan.
- 3) Two round live cartridges and one Golden Colour MI-5A Mobile Phone having IMEI No.- 862715044380053 & 862715048880058 with a Sim Card No.- 9748915442 & 8207788241 from the right pocket of Md. Saddam Alam S/O- Md Amin.
- 4) One dagger length about 30cm One Blue Colour Realme Mobile Phone having IMEI No.- 863611040331639 & 863611040331621 with a Sim Card No.- 620619\$979 from the waist of Md. Alam @ Alam Ansari @ Gawala S/O-Nabi Hussion Ansary

On being asked in respect of possessing the offending articles, they failed to give any satisfactory accounts in support of the offending articles. On interrogation they confessed that they were assembling to commit Dacoity at Rangadih village and for which they were using a TOYOTA QUALISH vehicle having Reg. No-JH05C/0803 which were parked in the thicket of Bidhan colony. I, accordingly, searched the thicket area of Bidhan colny and found the vehicle also as noted above. I, accordingly, seized & labeled the above noted articles under proper seizure list duly signed by the accused persons and Police personnel as there is no public were present at that time. Hence, I arrested them maintaining all the guidelines regarding arrest.

I on my arrival back to PS along with other officer and force with the arrested accused persons along with seized articles, lodge the complaint against the above noted accused persons to start a case under proper section of law.
