Respected Sir,

In producing here with one arrested accused person namely Badal Singh Sardar (58 yrs) S/O- Lt. Biru Singh Sardar of Vill.- Chotourma, P.S.- Balarampur, Dist. Purulia along with seized 12 (twelve) sealed country spirit bottles (DIL KHUSH) Each Bottle 600 ML (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 17:15 hrs. I received a credible source information that one Badal Singh Sardar (58 yrs) S/O- Lt. Biru Singh Sardar of Vill.- Chotourma, P.S.- Balarampur, Dist. Purulia is selling country spirit without any valid license from his own house at Chotourma village under Balarampur P.S., Dist.-Purulia. Accordingly, I inform to O/C Balarampur P.S. regarding this matter and as per order of O/C Balarampur P.S. I along with force left for Chotourma village to work out the source information. Thereafter we reached at Chotourma village at about 17:45 hrs as per source information and held raid in the house of Badal Singh Sardar.

During search with the help of accompany with force, we found that the said person is selling country spirit bottles (DIL KHUSH) in his own house. On demand, he failed to produce any valid documents or valid License in respect of selling and keeping of said country spirit. Accordingly, I seized all the sealed country spirit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled one bottle as a sample. Total 12 (twelve) sealed country spirit bottles (DIL KHUSH) Each Bottle 600 ML and arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909 after maintaining all the formalities as per NHRC guide line.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C) B.E. Act against the arrested accused person namely Badal Singh Sardar (58 yrs) S/O- Lt. Biru Singh Sardar of Vill.- Chotourma, P.S.- Balarampur, Dist. Purulia to start a cog case U/S 46A(C)B.E. Act and arrange for its investigation.
