I do here by brought under arrest two accused person namely (1) Bibekananda Mahato (age-35 yrs) S/O-Magaram Mahato of Vill-Janijhore, PS-Bandwan, Dist-Purulia (2) Chittaranjan Mahato (age-27 yrs) S/O-Debidas Mahato of vill-Jamjora, PS-Bandwan, Dist-Purulia along with five seized Motor Cycles (1) One Black & Blue Hero Glamour Motor Cycle having number plate No. JH-05B4/3407, Engine No. JA06FRJGH70319, Chassis No. MBLJAR027JGH59991. (2) One Black & Red colour Hero Super Splendor Motor cycle having Engine No. JA06EHJ9J21239, Chassis No. MBLJAR168J9J19176. (3) One Black & Red colour Hero Super Splendor Motor Cycle having Engine No. JA06EHJ9J21247, Chassis No. MBLJAR16XJ9J19227 (4) One Black & white colour Hero Honda Splendor Plus Motor Cycle having number plate No. BR-16K/1917, Engine No. HA10EFAHL03558, Chassis No. MBLHA10EZAHL73792 (5) One Black & Red colour Bajaj Pulsar Motor Cycle having Chassis No-MD2A11CZXHRK06557, Engine No-DHZRHK77469 and lodging written complaint against them, the fact of the case in brief is that today i.e. on 26/01/20 at 20:15 hrs I received a credible source information that one Bibekananda Mahato S/O-Magaram Mahato of Vill-Janijhore, PS-Bandwan, Dist-Purulia is habitually dealing with stolen Motor Cycles since long knowing that those were procured by means of theft. Accordingly, noted the fact in G.D which refers to Bandwan PS GDE No-1055, Dtd 26.01.20 and myself along with force (vide C.C No-233/20, Dtd. 26.01.20) left for Janijhore village to work out the said source information.

Then, I conducted search into the house of the said Bibekananda Mahato as per source information & seized four Motor Cycles (1) One Black & Blue Hero Glamour Motor Cycle having number plate No. JH-05BY/3407, Engine No. JA06FRJGH70319, Chassis No. MBLJAR027JGH59991. (2) One Black & Red colour Hero Super Splendor Motor cycle having Engine No. JA06EHJ9J21239, Chassis No. MBLJAR168J9J19176. (3) One Black & Red colour Hero Super Splendor Motor Cycle having Engine No. JA06EHJ9J21247, Chassis No. MBLJAR16XJ9J19227 (4) One Black & white colour Hero Honda Splendor Plus Motor Cycle having number plate No. BR-16K/1917, Engine No. HA10EFAHL03558, Chassis No. MBLHA10EZAHL73792 after preparing proper seizure list duly sign by witnesses as he failed to produce any valid documents in respect of seized Motor Cycles though sufficient time was given. During interrogation, he confessed that the seized Motor Cycles was procured by means of theft and he has been engaged in dealing with those kinds of stolen Motor Cycles since long. He further disclose that recently he had sale a stolen Motor Cycle to one Chittaranjan Mahato S/O-Debidas Mahato of vill-Jamjora, PS-Bandwan, Dist-Purulia and would help us to recover a good numbers of stolen Motor Cycles if get a chance as well as to secure arrest of their gang members. After that, I arrest him after prepare proper arrest memo duly signed by the witness.

Thereafter, I conducted search into the house of the Chittaranjan Mahato as per information of arrested accused person Bibekananda Mahato & seized One Black & Red colour Bajaj Pulsar Motor Cycle having Chassis No-MD2A11CZXHRK06557, Engine No-DHZRHK77469 after preparing proper seizure list duly signed by the witnesses from his (Chittaranjan Mahato) dwelling house as he failed to produce any valid documents in respect of said seized Motor Cycle. During interrogation, he had confessed that dishonestly he had purchased the said stolen motor cycle. After that, I arrest Chittaranjan Mahato (age-27 yrs) S/O-Debidas Mahato of vill-Jamjora, PS-Bandwan, Dist-Purulia after prepare proper arrest memo duly signed by the witness.

After returning to PS, I started Suo-Muto Bandwan PS Case No-05/2020, Dtd. 26/01/2020, U/S-379/411/413/414/120B IPC against arrested accused persons namely (1) Bibekananda Mahato (age-35 yrs) S/O-Magaram Mahato of Vill-Janijhore, PS-Bandwan, Dist-Purulia (2) Chittaranjan Mahato (age-27 yrs) S/O-Debidas Mahato of vill-Jamjora, PS-Bandwan, Dist-Purulia and other unknown miscreants.
