I do here by brought under arrest two accused persons namely i. Nityalal Mura (24 yrs) s/o-Budhu Mura of Vill-Satara, PS-Bandwan, Dist-Purulia and ii.Kalipada Hembram (38 yrs.)s/o-Lt. Satish Hembram of Vill-Choura, PS-Bandwan, Dist-Purulia along with two seized Motor Cycles 1. One Black & Blue colour Hero Passion Pro Motor Cycle having bearing Chassis No-MBLH10BUFGF03204, Engine No-HA10EUFGE02494 and 2. One Red & Black colour Hero Glamour Motor Cycle having bearing Chassis No-MBLJAR026HGM48253, Engine No-JA06ERHGM49316 and lodging written complaint against both of them, the fact of the case in brief is that today i.e. on 19.01.20 at17.05 hrs I received a credible source information that one Nityalal Mura (24 yrs) s/o-Budhu Mura of Vill-Satara, PS-Bandwan, Dist-Purulia is habitually dealing with stolen Motor Cycles since long knowing that those were procured by means of theft. Accordingly, noted the fact in G.D which refers to Bandwan PS GDE No-741 dtd 19.01.20 and myself along with force (vide C.C No-162 dtd. 19.01.20) left for Satara village to work out the said source information.

Then, I conducted search into the house of the said Nityalal Mura as per source information & seized One Black & Blue colour Hero Passion Pro Motor Cycle having bearing Chassis No-MBLH10BUFGF03204, Engine No-HA10EUFGE02494 after preparing proper seizure list duly sign by witnesses as he failed to produce any valid documents in respect of seized Motor Cycle though sufficient time was given. During interrogation, he confessed that the seized Motor Cycle was procured by means of theft and he has been engaged in dealing with those kinds of stolen Motor Cycles since long. He further disclose that recently he had sale a stolen Motor Cycle to one said Kalipada Hembram and would help us to recover a good numbers of stolen Motor Cycles if get a chance as well as to secure arrest of their gang members. After that, I arrest him after prepare proper arrest memo duly signed by the witness.

Thereafter, I conducted search into the house of the Kalipada Hembram as per information of arrested accused person Nityalal Mura & seized One Red & Black colour Hero Glamour Motor Cycle having bearing Chassis No-MBLJAR026HGM48253, Engine No-JA06ERHGM49316 after preparing proper seizure list duly signed by the witnesses from his (Kalipada Hembram) dwelling house as he failed to produce any valid documents in respect of said seized Motor Cycle. During interrogation, he had confessed that dishonestly he had purchased the said stolen motor cycle.

After returning to PS, I started Suo-Muto Bandwan PS Case No-04/2020 dtd. 19.01.2020 U/S-379/411/413/414/120B IPC against two arrested accused persons namely i. Nityalal Mura (24 yrs) s/o-Budhu Mura of Vill-Satara, PS-Bandwan, Dist-Purulia and ii.Kalipada Hembram (38 yrs)s/o-Lt. Satish Hembram of Vill-Choura, PS-Bandwan, Dist-Purulia and other unknown miscreants.
