Respected Sir,

In producing here with the arrested accused person namely Bachan Kumar (26 yrs approx), S/O- Bishnu Kumar@ Prajapati of Ward No-06,(Kumarkuli), Jhalda Municipality, PS- Jhalda, Dist- Purulia along with seized Country Spirit bottles (Details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 17:05 hrs I received a credible source information that one person namely Bachan Kumar, S/O- Bishnu Kumar@ Prajapati of Ward No-06, (Kumarkuli), Jhalda Municipality, PS- Jhalda, Dist- Purulia is stocking and selling Country Spirit without any valid license from his Tea-stall attached with his dwelling house at Ward No-06, (Kumarkuli), Jhalda Municipality, PS- Jhalda, Dist- Purulia. Accordingly, I along with force had been to the spot for Ward No-06, (Kumarkuli), Jhalda Municipality to work out the source information and held raid into the premises of above mentioned accused person at 17.15 hrs. I like to note here that seeing the Police personnel, customers were fled away. During search with the help of accompany force, we found that the said person is stocking Country Spirit bottles for sell. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of Country Spirit bottles. Accordingly, I arrest him after preparing proper arrest memo as he committed offence U/S 46 A(C) B.E. Act and supply one copy to him. Then, I seized all the sealed Country Spirit 10 bottles (DIL KHUSH each bottle containing 600 ml), 10 ltr. ID liquor contained in a white colored jarricane and sale proceed money (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled sample bottle. Total 06 liter Country Spirit and 10 Ltrs. ID Liquor and Rs- 320/- as sale proceed money has been seized, total value of the seized Country Spirit is RS 350/= (Three hundred and fifty only) and total value of ID Liquor is Rs-300/- (Three hundred) approx.

Under the above circumstances and fact, I therefore pray that a cog. case may kindly be started U/S 46A(C)B.E. Act 1909 against the arrested accused person namely Bachan Kumar, S/O- Bishnu Kumar@ Prajapati of Ward No-06,(Kumarkuli), Jhalda Municipality, PS- Jhalda, Dist- Purulia and arrange for its investigation.
