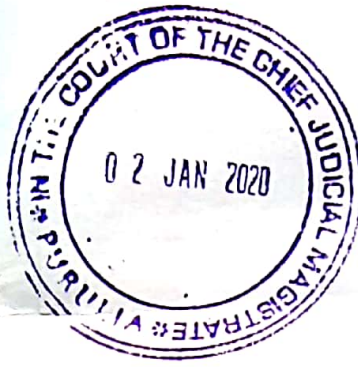

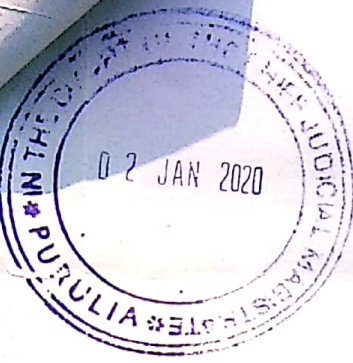

1.---That the above named Complainant is a poor man, for which some money has been sanctioned from the Pradhan-Mantri Aabas Yojana for making a house. He withdrawn 1st instalment from the said Aabas Yojana.

2.---That on 24-11-2019 corresponding to 7th Aghrayan 1426 B.S. he went to purchase Bricks and Cement, he had Rs. Rs.30,000/-(Rupees Thirty thousand) in his pocket for purchasing Bricks and Cement. 1stly he went to Tea Stall to meet the Vendor of the Bricks and Cement but said Vendor was not in the said Tea-Stall. So he started to return back to his house at about 5.30 P.M. at that time witnesses No. 3 and 4 Manoranjan Napit and Suren Mura also coming with him. When they reached at Koradih Gram Than, Accused Kabul Paramanik appeared from bush with Lathi and assaulted the complainant on his head with common intention to murdered the complainant. The complt. sustained blood injuries on his head. By that assault complainant fell down on the ground, then accused person Kabul Paramanik snatched Rs.30,000/-(Rupees Thirty thousand) from his Pocket, complainant tried to resist him but in vain. Accused taken away aforesaid money and he immediately fled away from the place of occurrence. Due to the fear witnesses No.3 and 4 also fled away from the place of occurrence. Complainant shouted for help and on bearing

the hulla witness No.2 Ramanath Kuiry and some villagers rushed to the spot.

3.---That there after the witnesses immediately took the injured/complainant to Jhalda Police Station by Ambulance and informed the incident ~~of~~ to the I.C.Jhalda, Jhalda P.S.sent to the injured/complainant to Jhalda B.P.H.C. After primary treatment Jhalda P.H.HC. referred to injured to Deben Mahato Sadar Hospital,Purulia on 25-11-2019. The complainant was admitted in the Sadar Hospital Purulia on 25-11-2019 as Indoor patient. He was treated in the Sadar Hospital,Purulia and discharged on 26-11-2019 but his treatment has been going on.

4.---That present accused person is very dangerous and desperate type of man.He has ill-reputed man.He is still threatening to kill the complainant.

5.---That the complainant was under the impression that police of Jhalda P.S. will start a police case against the accused person.But the police is quite mum and has not started any police case then complainant informed the aforesaid incident to S.P.Purulia,still police of Jhalda P.S.has not started any police case against the accused person.This is the reason of delay this case before this Hon'ble court.

Considering the facts and circumstances, it is therefore prayed that your honour will kind enough to send this complaint to I.C.Jhalda P.S. treating this petition as F.I.R.U/s 156(3) Cr.P.C.
