



Most respectfully beg to State :-

- 1) That both the complainant and accused persons are the resident of this District which is under your jurisdiction.
- 2) That the complainant was married with the accused No.-1) before 2 13 years.
- 3) That after one year of their marriage all accused persons started physical and mental tortures upon your petitioner.
- 4) That all the accused persons started giving pressure to your petitioner to bring money from her father for starting of their family business although the father of your petitioner gave a considerable amount to them in the name of starting a business by the petitioner no.-1 but he in lieu of starting business misued the fund to satisfy his bad habits. contd...p/3






That whenever your petitioner denied to bring money all the accused persons tortured her by way of keeping her without food, without propers dresses, without allowing her even to am use cosmetics.

- 6) That to bring peace in the family, the father of your petitioner gave about two lacs in installments during the time of after one year of their marriage, the installments of money was received by the accused no.-1 and no.-2.
- 7) That after two years of their marriage -a male child was born out of their wedlock namely Asib Ansary, presently 11 years old.
- 8) That the complainant silently bearing the tortures only considering the future of his son, but tortures happened on her contineously in a regular manner.
- 9) That several times your petitioner was driven out from the house, some time in the middle of night, but she was helpless and was compelled to live with them.
- 10) That on 04/06/2019 all the accused persons, called your petitioner in a room and the accused no.-1 and 2 directed her to bring about one Lac more from her father otherwise they threatended her even to murder her. She was panic sticken but help less, because she had knowledge that her father is unable to collect the money.





11) That on her refusal in doing so, all the accused person in a joined hands Started beating her by broom sticks, fist and blow, by legs catching her hairs, your petitioner started crying and than accused no.-1 and 2 catching her neck thrended her out from the house and directed them to leave the place to save her life. They did not allow her to take her son with her.

- 12) That on 10/11/2019 your petitioner lodged complaint before the I.C., Jhalda Police, but no step has been taken since date.
- 13) That on 18/11/2019 your petitioner filed a complain before the S.P. Purulia, but to no effect.
- 14) That all the accused persons with a common intention joined hands in torturing her contineously and have committed offences punishable under I.P.C. and other Acts.

In these situation, it is prayed that your Honour graciously be pleased to send this petition to the X I.C. Jhalda Police station with a order to treat this as F.I.R. as contemplated U/s. 156(3) Cr.p.c.and after investigation to initiate a criminal proceeding agains all the accused person.
