I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Shibeswar Karmakar, S/O-Ram Karmakar of village-Mantard, P.S- Joypur, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 06.01.2020 at about 03.10 P.M. I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 01.Ganesh Mahato Gr1 TSH, Joypur CCC 02. Shibaram Mahato, HG TSH, Joypur CCC, entered the premises of Shibeswar Karmakar, S/O-Ram Karmakar of village-Mantard P.S- Joypur, Dist- Purulia and found Shibeswar Karmakar, S/O-Ram Karmakar was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSEDCL through CU cable black and green colour by means direct hooking to his house premises and connected load found 0.9 KW. As Shibeswar Karmakar, S/O-Ram Karmakar committed theft of electric power. So, I seized the following articles after preparing the seizure list in presence of 01.Ganesh Mahato Gr1 TSH, Joypur CCC 02. Shibaram Mahato, HG TSH, Joypur CCC. The inspection team left the premises at 03.45 P.M.
