I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Faruque Ansari, S/O-Gafur Ansari of village-Hinjori Shyampur, P.S- Joypur , Dist- Purulia has committed theft of electricity U/S 135(1) (b) of electricity act 2003 subsequently amendment act 2007.

On 07.01.2020 at about 03.05 P.M . I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 01.Ganesh Mahato Gr1 TSH,Joypur CCC 02.Shibaram Mahato,HG TSH,Joypur CCC, entered the premises of Faruque Ansari, S/O-Gafur Ansari of village-Hinjori Shyampur P.S- Joypur , Dist- Purulia and found Faruque Ansari, S/O-Gafur Ansari was enjoying electricity unauthorizedly drawing power from the incoming service line of WBSEDCL through PVC black colour(4 sq. mm) with tapping arrangement by means meter bypassing to his house premises and connected load found 0.505 KW. As Faruque Ansari, S/O-Gafur Ansari committed theft of electric power.So, I seized the following articles after preparing the seizer list in presence of 01.Ganesh Mahato Gr1 TSH,Joypur CCC 02.Shibaram Mahato,HG TSH,Joypur CCC. The inspection team left the premises at 3.35 P.M.
