I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Magaram Kumar, S/O-Chandramohan Kumar of village-Hetkahan Kumardih, P.S- Joypur , Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 07.01.2020 at about 04.12 P.M . I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 01.Ganesh Mahato Gr1 TSH, Joypur CCC 02.Shibaram Mahato, HG TSH, Joypur CCC, entered the premises of Magaram Kumar, S/O-Chandramohan Kumar of village-Hetkahan Kumardih P.S- Joypur , Dist- Purulia and found Magaram Kumar, S/O-Chandramohan Kumar was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSEDCL through white colour CU cable with hooking arrangement by means direct hooking to his house premises and connected load found 0.2 KW. As Magaram Kumar, S/O-Chandramohan Kumar committed theft of electric power. So, I seized the following articles after preparing the seizer list in presence of 01.Ganesh Mahato Gr1 TSH, Joypur CCC 02.Shibaram Mahato, HG TSH, Joypur CCC. The inspection team left the premises at 4.45 P.M.
