Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Shyamal Chatterjee S/O-Lt Gurupada Chatterjee, Vill.-Dhatla ; PO-Tara, Dist-PURULIA has committed theft of Electricity U/S-135(1)(a)(b) of the Electricity Act 2003,(Amendment) Act-2007.

On dated 07.01.2020 I received a secret complain over telephone that Sri Shyamal Chatterjee S/O-Lt Gurupada Chatterjee, Vill.-Dhatla , Po-Tara, Dist-PURULIA consuming electricity by means of tapping from service cable before entering the meter of WBSEDCL. .

On the basis of said complaint at about 11.00 AM. I, Sri Dipak Kumar Bhowmik, Sub Assistant Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with,

- 1) Sri Sanjoy Garain, OE, Kashipur CCC
- 3) Sri Fakir Bauri, GR-1 TSH Kashipur CCC.

Entered the premises of Sri Shyamal Chatterjee after serving notice and inspected his installation in presence of villagers. During inspection it has been found that he is consuming electricity dishonestly by means of tapping bypassing meter for registering actual consumption against consumer id 242058510 Total Load found approx 0.5 KW (CFL-10 nos. TV-01 Nos)

Then we disconnect his permanent connection and seized the following articles.

- 1) Tapping point of service cable 1 meter (approx) along with.
- 2) Bulb with Holder 01 Nos

After preparation of proper seizure list The seizure list are prepared at the site and the representative of accused person refuse to sign in the seizer list. The inspection team left the above premises at about 11.25 AM. The accused person has committed an offence U/S-135(i)(a)(b) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
