I Sri Prashant Kishor, S/O - Kishori Prasad, A.E. & Station Manager of Telkalpara CCC of WBSSEDCL do hereby lodge my complaint empowered by the Electricity (Amendment) Act-2007 to the effect that Santosh Mahato S/O Lt. Arun Mahato of Vill - Kantasiary, PS-Kenda has committed theft of electricity under section 135(1)(a) as detailed here under.

Today, i.e. on 11.01.2020 I, Prashant Kishor (AE&SM), along with Sri Chinmoy Maity, JE(Gr-1)(E) and Sri Tapan Kumar Rajwar, L.M. of Telkalpara CCC, WBSSEDCL conducted a raid programme at village Kantasiary under Kenda P.S. When our team at about 11.00 A.M. entered to the Poultry farm premises of Santosh Mahato, we found that he was enjoying electricity dishonestly by means of Direct hooking from nearest LTOH line and run poultry farm, thus WBSSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, hooking wire dismantled and seized and seizure list prepared. The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 11.30 A.M. after completion of inspection & necessary formalities.

Santosh Mahato S/O Lt. Arun Mahato of Vill -Kantasiary, PS-Kenda has committed theft of electricity under section 135(1)(a) of the Electricity (Amendment) Act-2007.
