I Sri Prashant Kishor, S/O - Kishori Prasad, A.E. & Station Manager of Telkalpara CCC of WBSSEDCL do hereby lodge my complaint empowered by the Electricity (Amendment) Act-2007 to the effect that Bijoy Singh S/O Ram Singh of Vill - Tara, PS-Kenda has committed theft of electricity under section 135(1)(a) as detailed here under.

Today, i.e. on 13.01.2020 I, Prashant Kishor (AE&SM), along with Sri Chinmoy Maity, JE(Gr-1)(E) and Sri Tapan Kumar Rajwar, L.M. of Telkalpara CCC, WBSSEDCL conducted a raid programme at village Tara under Kenda P.S. When our team at about 10.00 A.M. entered to the Domestic premises of Bijoy Singh, we found that he was enjoying electricity dishonestly by means of Direct hooking from nearest LTOH line and run domestic appliances, thus WBSSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, hooking wire dismantled and seized and seizure list prepared. The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 10.30 A.M. after completion of inspection & necessary formalities.

Bijoy Singh S/O Ram Singh of Vill -Tara, PS-Kenda has committed theft of electricity under section 135(1)(a) of the Electricity (Amendment) Act-2007.
