Most respectfully begs to state as follows:-

1. That the complainant is now residing at Vill.-
Challah under P.S.Manbazar, Dist.Purulia and accused
persons are the permanent resident of Vill.Hirsingdih,
under P.S.Manbazar, Dist.Purulia within the jurisdiction
of Honourable court.
2. That one day in the year 2011 accused persons namely
Souridas, Sisir Namata and his son Sudha Namata of Vill.-
Hirsingdih under P.S.Manbazar, Dist.Purulia had apprao-
ched at the house of your complainant and requested your
complainant to purchase R.S.Plot Nos.123, 124 and 125
which were recorded in the name of accused no.1 and on
good faith your petitioner ready to purchase the afore-
said plots total area 20 decimals and the consideration
amount was settled Rs.80,000/- in presence of the deed
writer and accordingly a sale deed was prepared on
2.11.2011 but prior to presentation of deed before the
deed register complainant some how able to know that
accused persons already sold the aforesaid land to ano-
ther person as such the written deed was not submit before
the deed register.
3. That by the intervention of local people, Panchayet
and some other respectable person it was settled that

accused will execute the deed in lieu of aforesaid plots within R.S. Plot No. 127 of the same mouza where the accused have considerable land as per market value in respect of paid amount which already ^{been} paid to the accused but on several dates ~~amicably~~ ^{was made} settlement ^{but} ~~amicably~~ deed not turned up to execute the deed.

4. That on 14.2.2019 by the intervention of village people it has been settled in between complainant and accused persons, that accused persons will execute the sale deed of R.S. Plot No. 127 of mouza Birsinghi for the previous payment in lieu of R.S. Plot No. 123, 124 & 125 and another agreement was prepared on the same day and the accused person took Rs. 100000/- (One lakh) as advance money for the execution of deed and the rate has fixed Rs. 15000 per decimals and it also settled that accused will be bound to execute the deed for previous amount and this agreement amount within few days ^{and} the accused took the money by preparing a money receipt payment upon the it revenue stamp.

5. That ^{thereafter} on several time your complainant requested the accused to comply the agreement as well as the ~~agreement~~ which given in presence of members of Panchayat but instead of performed agreement and assure the accused threaten your complainant for dire consequence

that "your ~~name~~ Hindivasi ja karar kome Ne"

6. That ~~by~~ the good faith your complainant believed the version of the accused persons as such your complainant did not paid the amount of RS.100000/- apart from the previous payment but ultimately as and when accused denied to execute the deed your complainant fully ~~satisfy~~ that the accused persons cheated the complainant for the 2nd time by taking advantage of Hindivasi.

8. That having no other alternative petitioner informed the matter before the P.S. on 23.4.19 but ~~in~~ the P.S. did not took any steps against the ~~accused persons~~.

9. That your complainant after waiting long time on 28.11.19 informed the matter to the S.P. Purulia but all in vain.

10. That there is every chance of search and seizure of material evidence as well as the statement of witnesses and having no other alternative your petitioner take the shelter of sec.156(3) C.P.C. to establish ^{the} truth and to ~~Booked~~ ~~up~~ ~~the~~ criminal as per provision of law in u/s. 420 and 468 I.P.C.

It is therefore prayed that your honour may graciously be pleased to send this complaint petition before the C.C. Harbazan P.S. after treating the same as P.I.R. for investigation and necessary action as per sec.156(3) Cr.P.C. for the ends of justice
