Sir,

In producing here with one accused person Bhandu @ Shyamapada Bauri (58yrs approx) S/O Lt Prahallad Bauri of village- Ashanboni, PO- Pedda PS- Manbazar, Dist- Purulia along with following seized articles viz-

- (1) 20 (Twenty) Ltrs ID liquor within a Jarikan
- (2) 15 pieces plastic glass
- (3) Sale proceed of Rs- 125/-

I S.I. Sujit Das of Manbazar PS do here by lodged a complaint against accused namely Bhandu @ Shyamapada Bauri (58yrs approx) S/O Lt Prahallad Bauri of village- Ashanboni, PO- Pedda PS- Manbazar, Dist- Purulia to the effect that today (09.01.20) at 16:15 hrs. I received a telephonic information from a reliable source that one Bhandu @ Shyamapada Bauri (58yrs approx) S/O Lt Prahallad Bauri of village- Ashanboni, PO- Pedda PS- Manbazar, Dist- Purulia has stocked ID liquor illegally and selling the same after hike price for his personal gain. I noted this information in GDE vide Manbazar PS GDE No-352 Dtd 09.01.20. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/1412 Susanta Patra, C/1183 Subash Kundu rushed to the spot for conducting raid by Govt. vehicle. At about 17:35 hrs myself along with force reached at Ashanbani village and held raid at the house of Bhandu @ Shyamapada Bauri and found that said house owner selling ID liquor in his own dwelling house. Seeing the Police party some persons fled away and said Bhandu @ Shyamapada Bauri tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly sign by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Bhandu @ Shyamapada Bauri (58yrs approx) S/O Lt Prahallad Bauri of village- Ashanboni, PO- Pedda PS- Manbazar, Dist- Purulia as per law and arrange for its investigation.
