I do hereby lodge complaint empowered by enabling the IE Act 2003 subsequently (amendment at 2007) to the effect that On today (06-01-2020) at about 16:10 hrs he was enjoying electricity unauthorisedly i.e. bypassing the energy meter and due to this reason he has committed theft of electricity u/s 135 (1)(b) of the electricity act 2003 duly amended on 2007 in spite of having a authorized connection against consumer id 242103516

On 06-01-2020 at about 16:10 Hrs I Sri Gotirmoy Dass Station Manager, Saltore Customer Care Center along with:-

Entered the premises of Sri Ashoke Das of Village: Dudhiapani Ps. Neturia Dist. Purulia and inspected his/her premises. During inspection theft of electricity was detected i.e. he/She was using electricity dishonestly by bypassing the incoming service cable and without registering the consumption in the energy meter i.e. u/s 135 (1)(b) was detected.

From the above arrangement he/she was using the following electrical equipments:-

1. Color TV - 03 nos (80 watt each)
2. Electric Fan - 06 nos (80 watt each)
3. CFL - 08 nos (09 watt each)
4. Electric Bulb - 03 nos (100 watt each)
5. Freeze - 01 nos (120 watt)

Out of which I seized the following:-

1. PVC 2 core with bypassing arrangement - 05 feet (approx.)
2. Electric Bulb with holder - 02 nos

Seizure list was prepared at the site and accused person refused to sign/Signed on the seizure list.

The service connection against consumer ID 242103516 was disconnected from pole side.

The inspection team left the premises at about 16:30 Hrs. on 06-01-2020

The Accused person has committed an offence U/S 135(1) (b) of the electricity Act 2003 amended on 2007.
