During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by direct hooking from over-head LT line by pvc wire

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- ① 2 NOS FAN - 160Watt, ② 1 NO TV - 100 Watt, ③ CFL Lamp - 2 NOS (20 Watt)

Out of which we seized the following.

- ① PVC cable (approx - 3m)
