During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by tapping incoming side of service cable

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- ① Tube light - 2 NOS (80 watt)
- ② CFL - 4 NOS (80 watt)
- ③ Fridge - 1 NO (180 watt)
- ④ Fan - 4 NOS (320 watt)

Out of which we seized the following:

- ② Incoming Service Cable - (1m approx) with tapped portion


