Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that **BIJOY SEN, S/O- LATE PARITOSH SEN of VILL- Para ,P.O.- Para, P.S.-Para, Dist-Purulia** the user of the electric has committed an offence of theft of electricity under section 135 (1)(b) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.

On 24.01.2020 at about 10.00AM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with, Nimai Chandra Mahato , TSH of Dubra Para CCC, Bhaktipada Mahato TSH of Dubra Para CCC, WBSEDCL inspected the premises of **BIJOY SEN, S/O- LATE PARITOSH SEN of VILL- Para ,P.O.- Para, P.S.-Para, Dist-Purulia WBSEDCL**. During inspection it was found that the said **BIJOY SEN** was enjoying electricity unauthorizedly by direct tapping of service cable as hooking arrangement from WBSEDCL's nearest low tension over head line for running his 01 no Heater of 1KW, and 02 nos LED of 09watts each and 02 nos ceiling fan of 65watts each, approx load **1.148KW** for domestic purpose, which is an offence u/s. 135 (1)(b)of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 10.20 am.

As such **BIJOY SEN, S/O- LATE PARITOSH SEN of VILL- Para ,P.O.- Para, P.S.-Para, Dist-Purulia** has committed an offence of theft of electricity under section 135 (1)(b) of Electricity Act. 2003 read with amendment of Electricity Act. 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
