- 2. That be it mentioned here that they regularly used to serve food to the patients of Block Primary Health Centre, Puncha which is situated at Puncha, since last seven years and



and there is no adverse report against the above said self help group, not only that, the B.M.O.H. restord certificathe above said self help group.

- That, it on 1.9.19 when the complainant and her member 3. of self help group, went to the kitchen of Puncha B.P.H.C. at that time, the above said accuseds with other 14/15 persons stopped the complainant and her companion, and told, the complainant that you will no longer coocked and serve the food to the patients of the Puncha B.P.H.C. with a filthy languages, which is sufficient to derogate a female in the public place, which amounts to a outrage of modesty. Be it mentioned here that, the above said accuseds are backed by present rulling party of the state of W.B. and the Dulal Dutta is a vetun litigant, he always create pressure to the officials of any department of state govt, and take illegal advantage.
  - That, it is further submitted that, the complainant ab served that, the above said accused brocke open the lock of the kitchen and took away the utengils and other equipments of the cooking and create wrongful loss worth Rs. 7/8 thousand to the complainant as well the said self help group, the complainant protested against such illegal act, but the said Dulal Dutta flatly stated that, "we all the accuseds took away your utengils" and tried to touch the body of the complainant to assault your complainant, seeing the valant attitude of the all accuseds the complainant and other members of the self help group fled away from the place of occurance, then and there, your complainant went to makiking was Thana and lodged complaint, but due to

political pressure the police of Puncha P.B.did not take any action, the complainant inform the matter to the S.P.Purulia, but S.P.also did not take any action.

Hence this delay, your petitioner is poor lady, and she has no capacity to continue the case in her own capacity, more so, there some matter of seizer, so police investigation is very much required.

Under the aforesaid circumstances it is, therefore prayed that your Honour may kindly be pleased to admit this criminal misc.petition and to send it to the O.C.Puncha P.S.for starting a specific case against the aforesaid accuseds after treating this petition as an F.I.R.u/s.156(3) cr.P.C.
