

father of the complainant was sitting outside near the residential house at that time one Habulal Baskey started using abusive languages towards the father of the complainant and all of a sudden the father of the complainant was attacked by a sharp cutting weapon by said Habulal Baskey and injured on the forebead of the father of the complainant. That Shukuntala Baskey, the wife of Habulal Baskey also assulted on the kft left side of the head of the father of the complainant. There was attempt made by the accuseds and started heating with fist and blows. Poth the accuseds have common intention of them. Sukdeh Murmu, the father of the complainant raised hallah and cried for help at that time the village people rushed to the spot and rescued the father of the complainant.

- 4. That the injury of the father of the complainant was grievous in nature.Local people shifted the injured Sukdeb Murmu to Puncha B.P.H.C. and he was admitted there.
- 5. That lateron the injured Sukdeb Murmu was admitted at XXX Bankura Sammilani Medical College and Hospital on 30-9-2019.
- 6. That the complainant lodged a written complaint to the O.C. Puncha P.S. on 29-9-2019 against the aforesaid accuseds. But reason best known to the O.C. case was not started against the aforesaid accuseds.

Therefore having no other alternative the complainant lodged a written complaint x to the S.P.Purulia on 17-10-2019 against the aforesaid accuseds.
