Sir,

In producing herewith the arrested accused persons namely (i) Ramjan Middya (47yrs) S/O Sabed Middya of Vill- Dhagaria PO Hamirpur, PS- Patrasayer, Dist- Bankura (ii) Ramesh Sahis (36 yrs) S/O Late Hem Sahis of Vill-Nekre PS- Balarampur, Dist- Purulia and one seized vehicle (Medium truck) having registration number WB 55A 1460 loaded with approx 08 tons paddy in gunny bags.

The nub of the fact in a nutshell is that today (22.01.2020) I ASI Sudip Mukhapadhyay along with C/877 Basudeb Mahato C/778 Sanjay Chowdhury was performing Patrolling duty vide Tamna OP CC No 70/2020 and Tamna OP GDE No 631 Dated 22.01.2020. During my Patrolling duty along Purulia-Tata Road received credible source information at about 20:05 hrs that a Medium truck loaded with stolen paddy was coming from Balarampur side towards Purulia Town. Subsequently I along with force reached at Tamna More and intercepted the said vehicle at about 21:15 hrs and found on searching that the medium vehicle as well as its goods was identical as I received the prior information. On being asked, the driver of the said vehicle and his concomitant disclosed their names as noted supra. I asked the driver Ramjan Middya to produce the valid document in respect of the vehicle as well as the goods loaded on the vehicle. But the driver of the vehicle could not produce any document in respect of the vehicle and the goods loaded on the vehicle. I asked repeatedly but they stated differently in different times. The incoherent statement of the driver and his concomitant purported to be a suspicious one to us. After the prolong interrogation they confessed before us that the vehicle, loaded with paddy was stolen from Jharkhand border side and proceeded towards Purulia for its disposal. The driver, Ramjan Middya and his concomitant, Ramesh Sahis confessed their guilt, and they were directly involved in dealing with stolen property. The driver and his concomitant also stated that they had been running clandestine business of stolen property since long by dealing with paddy for a wrongful gain. As such there was every reason to believe that the driver, Ramjan Middya and his concomitant were habitually dealing the stolen property. So they are liable for offence punishable U/S 379/411/413/414 of the IPC. Subsequently, I seized the vehicle (Medium Truck) having registration number WB 55A 1460 loaded with approx 08 tons paddy in gunny bags preparing proper seizure list in presence of my accompanied staffs and also arrested the accused driver and his concomitant namely (i) Ramjan Middya (47yrs) S/O Sabed Middya of Vill- Dhagaria PO Hamirpur, PS- Patrasayer, Dist- Bankura (ii) Ramesh Sahis (36 yrs) S/O Late Hem Sahis of Vill- Nekre PS- Balarampur, Dist- Purulia informing the ground of arrest and issued Memo of arrest and Inspection Memo against the both accused persons.

Therefore I pray before you that a specific case against accused persons namely ((i) Ramjan Middya (47yrs) S/O Sabed Middya of Vill- Dhagaria PO Hamirpur, PS- Patrasayer, Dist- Bankura (ii) Ramesh Sahis (36 yrs) S/O Late Hem Sahis of Vill-Nekre PS- Balarampur, Dist- Purulia may kindly be started and arrange for its investigation.
