hear my request. All the accused persons forcibly caught

hold my hand and forcibly fell down on the ground and they torn my wearing apprels and started assaulting my be lathi and fist and blow. I shouted for help and the accues persons fled away and when they fled away, the had taken some of Rs.2,000/- from my pokepockets. I raise hallah the accused persons threatned me in various way by giving offensive languages on the point of sharp cutting weapons on my neck. The witnesses being attracted the hallah came to the spot but as the accused persons armed With deadly weapons they could not do anything. There after the matter was brought to the O.C.Purulia (M) P.S. and the Police Officer assured me that appropriate legal action would be taken against them but unfortunately till today no action or any specific case has yet been started against the accused persons and the accused persons still threatening in various way.

2.---That thereafter the complainant submitted Written Complain before the S.P.Purulia on 10-12-2019 but the S.P. also has taken no steps hence this petition is filed before the Ld. court and delay has been caused.

3.---That the accused persons have committed offence hence they should be punished according to law.

(M) P.S. with a direction to investigate
the facts of the case treating this
