

- 3. <u>Nature of offence committed:</u> under section 395/392/120 B/ 34 read with section 406/420 of Indian Penal Code.
 - Date, time and place of occurrence: 16/09/2019, under Raghunathpur P.S. within the jurisdiction of your ld. Court.

•That the defecto complainant most respectfully beg to state as follows:-

- 1. that the accused on 16/09/2019 at about 8 PM with 4 unknown person restrain the vehicle no. WB-82-B-1737, which was at that time drive by the complainant, near GHOSAL PETROL PUMP, Raghunathpur, on Barakar Purulia Road and put the complainant in fear of instant hurt, and commit docaity/robbed the above noted vehicle from the possession of the present complainant, and thus committed the offence under section 395/392/120B/34 IPC.
- 2. That the complainant and the above noted accused person no. 1 are known to each other and the complainant for the purchase of the above noted vehicle, paid Rs. 4,30,726/-(four lakh thirty thousand seven hundred twenty six rupees) to the accused no. 1 and the finance company of the above noted vehicle through bank account, and took the possession of the vehicle on 26/08/2018, and lateron when the accused denied to change the ownership of the above noted vehicle, then the complainant—serve legal notice vide dated 16/09/2019, to the accused no. 1 with information to Raghunathpur Police station and Para police station, through his lawyer and also informed about the matter to the accused person through phone by the complainant.(Xerox copy of legal notice with Courrier Receipt and

- 3. That on the very date of issuing notice, the above named accused person no. 1 along with other committed the offence, of 395/392/120B/34, and also the accused no. 1 cheated the complainant and also there is every chance of misappropriation of the amount as well as the vehicle subjected and thus committed offence under section 406/420 IPC and when the complainant approach to Raghunathpur Police Station, he was not responded by the concern police station.
- 4. That on the next day the complainant made written complainant to S.P. Purulia, as well as I/C, Raghunathpur for the above noted offence, through registered post. (Xerox copy of application with postal receipt and acknowledgement is annexed herewith, which will form part of this application.)
- 5. That till today neither the S.P., Purulia nor the I/C, Raghunathpur P.S. took any initiative for the redressal of the grievance of the complainant, and finding no other alternative, the complainant took the shelter before the Id. Court for the prayer made herein below.

It is therefore prayed before the Id. Court may kindly pass necessary order to Inspector in Charge, Raghunathpur Police station to treat the same as FIR under section 156(3) Cr.P.C., and any other order/orders, direction/directions, as your Id. Court may deem fit and proper for the ends of Justice, And for this act of kindness the complainant shall ever prays.
