Raghunathpur admitted Arjun Singh at Raghunathpur primary hospital but seeing the critical condition of Arjun Singh he was referred to Ranchi medical college where he succumbed on 06/11/2019.

- 3) That, the accident took place due to rash and negligent manner of the driving by the driver of the said unknown truck.
- 4) That, your petitioner had been to Raghunathpur police station but no any F.I.R was lodged till date.
- 5) That, your petitioner also informed the S.P Purulia, but no any action was taken place and no any F.I.R is lodged till date by the police of Raghunathpur P.S. hence this application.
