Sir,

In producing here with one arrested accused namely Milan Mal (24 Yrs) S/O Subhas Mal of Vill- Kamaldanga, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 15 bottles (in sealed condition) DIL KHUSH country spirit, 600-ml each bottle, Rs-35 of each bottle.

I ASI Tapas Kr. Panda, of Adra PS do here by lodged a complaint against accused namely Milan Mal (24 Yrs) S/O Subhas Mal of Vill- Kamaldanga, PS-Adra, Dist- Purulia to the effect that on 11/02/20 at about 20:45 hrs in course of my special mobile duty I received a telephonic information from a reliable source that one Milan Mal (24 Yrs) S/O Subhas Mal of Vill- Kamaldanga, PS-Adra, Dist- Purulia has been stocked of country spirit illegally at his dwelling house and selling the same to hike price for his personal gain. After getting such information I informed to my O/C and as per his direction I along with my accompanied force reached at Kamaldanga village at about 21:45 hrs. and hold raid in the house of said Milan Mal and found that the said person selling liquor at his house and after seeing the Police party some person fled away and said Milan Mal has try to concealed himself but I able to apprehend him with help of accompanied force and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Milan Mal selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest.

Hence I there for pray that a specific case may kindly be started against arrested accused Milan Mal (24 Yrs) S/O Subhas Mal of Vill- Kamaldanga, PS-Adra, Dist- Purulia under proper section of law.
