inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly
by draining current bypassing from incoming
service cable before energy Meter.

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- ① Pump - 1 HP = 746 watt ② CFL - 3 Nds = 54 watt
③ Fan - 2 Nds = 120 watt

Out of which we seized the following:

2 mtr service cable with bypassing arrangement.

The seizure list is prepared at the site and the accused person signed in the seizer list.

The inspection team left the above premises at about 3:40 PM on dated 05/02/2020 The
accused person has committed an offence U/S-135(i)(B) of the Electricity (Amendment) Act-2007.
