Entered the premises of Md. MUSTAK, s/o Lt Md Subhan of Village- Chunabhati, P.O- Adra, P.S- Adra, Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by drawing illegal bypassing from incoming Service cable before energy meter.

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- ① Induction oven - 1 No's = 1000 watt
- ③ CFL = 1 No's = 18 watt
- ② Fan - 1 No's = 60 watt

Out of which we seized the following:

1.5 meter cable with 15A switch board.
