Entered the premises of Md. MUSTAK, s.o. Lt Md Subhan of Village- Chunabhati, P.O- Adra, P.S- Adra, Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by drawing illegal bypassing from incoming service cable before energy meter.

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- ① Induction oven - 1 No's = 1000 watt
- ② Fan - 1 No's = 60 watt
- ③ CFL = 1 No's = 18 watt

Out of which we seized the following:

1.5 meter cable with 15A switch board.

The seizure list is prepared at the site and the accused person signed in the seizer list

The inspection team left the above premises at about 04:16 PM on dated 05/02/2020. The accused person has committed an offence U/S-135(ii)(B) of the Electricity (Amendment) Act-2007.
