In producing here with one arrested accd namely Satyaban @ Amrit Mahato (33) S/O Arun Mahato of vill Haranama P.S.-Arsha Dist-Purulia along with following seized articles viz –

- 1) One white colour plastic container with approx 10 ltrs of cholai,
- 2) One white colour plastic container with approx 09 ltrs of cholai,.
- 3) Approx 375 ml taken out from Sl No. 1 white plastic container as sample with wax
- 4) Approx 375 ml taken out from Sl No. 2 white plastic container as sample with wax

I, SI Basudev Samanta of Arsha PS do hereby lodged a written complaint against the above noted accused person to the effect that today 03.02.2020 I along C/- 744 Susanta Chakraborty of Arsha PS and C/- 532 Subhankar Mandi left for day mobile duty vide Arsha PS CC No. 231 Dtd- 03.02.2020 & Arsha PS GD No. 73 Dtd- 03.20.2020. During mobile duty at about 17: 25 hrs when we are on way to Layadih village under Arsha PS we found one person with a yellow colour bag with his hand, seen us to proceed toward him, the person tried to flee away. Somehow we manage to intercept him and found approx 19 ltrs of colourless liquid smelling like cholai inside 02 containers. On asking I confirmed that the liquid is cholai and he disclosed his name as maintained above. I also informed that he will transport this cholai spirit to other village. He failed to produce any valid documents to posses & transport this cholai spirit. So, I seized all the implicating article as noted above under a proper seizure list from his exclusive possession in presence of witness and properly sealed and labelled duly signed by the accused person and witnesses among which 02 bottle of cholai approx 375 ml taken out from each of the above containers as sample packed with sealing wax. During interrogation he confessed his guilty so, I arrested him after observing all the formalities issuing memo of arrest as the accused persons are liable for prosecution u/s 46A(c) of The Bengal Excise Act,1909.

I therefore pray that a specific case may kindly be started against the accused namely Satyaban @ Amrit Mahato (33) S/O Arun Mahato of vill Haranama P.S.-Arsha Dist-Purulia U/S 46A(c) The Bengal Excise Act,1909.
