Mondal S/o Mr. Nibaran Mondal resides at vill- Hetyadih, P.O - Supurdih,  
P.S - Balarampur, Dist - Purulia to the effect that received an information, that the  
abovesaid accused person is committing theft of electricity in his residence by  
way of direct hooking from the LTOH Line of WBSEDCL.

Acting upon such information on 03.02.2020 from 7.50 AM to 8.40 AM, I  
along with Sri Manab Kr. Maji, J.E (E) Gr II, Sri Arindam Chatterjee, O.E Balarampur  
CCC and technical persons of M/s. Rahul Traders (Enlisted Agency of WBSEDCL)  
inspected the premises of Sanatan Mondal and held raid.

During raid and inspection it was detected that accused Sanatan Mondal  
is using electricity dishonestly by making direct hooking from the nearby  
LTOH Line of WBSEDCL for running one electrical motor operated Paddy  
brushing machine and 1 no 9 watts LED Lamp having total connected load  
of 0.382 kW

I prepared inspection report in presence of the Accused and assessed the  
load as 0.382 kW. Details have been mentioned in the inspection report  
duly signed by the accused.

I directed Sri Sanjoy Mahanty, Skilled Employee of M/s. Rahul Traders (Enlisted Agency of WBSEDCL) to disconnect the hooking line/arrangement from our LTOH Line. Accordingly they disconnected the aforesaid hooking line/arrangement from LTOH line.

I prepared seizure list in presence of the accused & witnesses, details of seizure have been mentioned in the seizure list duly signed by the accused. The paddy brushing machine could not be seized due to its odd size only the electrical motor coupled with the said machine is seized. A copy of the Seizure List was handed over to the accused. The local people gathered ~~there~~ there witnessed the incident but refused to sign on the Seizure List and inspection report.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence up 135 (i) (a) of Electricity Act 2003 (Amended in 2007)

Kindly treat this complaint as FIR and take necessary action against the accused.
