of Balarampur CCC of WBSEDCL do hereby lodge complaint against Sri Sitaram
Dutta, s/o Lt. Krishna Dutta resides at vill - Goshala Road, Balarampur, Po - Raugadia
P.S. - Balarampur, Dist. - Purulia to the effect that received an information that the
aforesaid accused person is committing theft of electricity in his residence by way
of tapping the incoming service cable to bypass the proper registration of units in the
Energy Meter of WBSEDCL.

Acting upon such information today on 11.02.2019 from 2.20 PM to 3.10 PM, I along with
Sri Manab Kr. Maji, J.E Sr II, Balarampur CCC, Sri Arindam Chatterjee, OE Balarampur CCC
and technical persons of M/s Ajoy Kr. Ghosh (Enlisted Agency of WBSEDCL) inspected
the premises of Sri Sitaram Dutta and held raid.

During raid and inspection it was detected that accused Sitaram Dutta is using
electricity dishonestly by way of tapping the incoming service cable to bypass the
proper registration of units in Energy Meter of WBSEDCL. Through his bypass
arrangement he is using 100watts Lamp - 2 Nos, E Rickshaw Charger - 1 No, LED Lamp 9W -
3 Nos, Ceiling Fan - 3 Nos, Tv - 1 No having total connected load of 1.167 KW including
5 Nos 40watts Fluorescent Tube Light. The service connection of WBSEDCL bearing consumer
ID 242032541 stands recorded in the name of the accused, has been

disconnected upon detection of theft of Electricity.

I prepared inspection report in presence of the accused ~~to be~~ and assessed the load as 1.167 KW. Details have been mentioned in the inspection report duly signed by the accused.

I directed Sri Rajib Sahis, Supervisor of M/s. Ajoy Kr. Ghosh (Enlisted Agency of WBSEDCL) to disconnect the Service Connection of the above ~~mentioned~~ stated Consumer ID. Accordingly he disconnected the aforesaid Service Connection and removed the incoming service cable with bypass arrangement.

I prepared Seizure List in presence of witnesses, details of seizure have been mentioned in the seizure list and obtained signature of the accused. A copy of the seizure list was handed over to the accused. The local people gathered their witnessed the incident but refused to sign on the seizure list and inspection report.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offense u/s 135(i)(a) & 135(i)(e) of Electricity Act 2003 (Amended in 2007)

Kindly treat this complaint as FIR and take necessary action against the accused.
