Entered the premises of Kartick Kumar Vill. Pat Jhalda P.S. Jhalda Dist- Purulia, having Consumer No. 242136855 Meter No. IPBB24748 and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(1) (a) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 2) Electric fan - 04 nos
- 3) Electric Bulb - 03 nos
- 4) Color TV - 01 no
- 5) CFL - 04 nos

Out of which I seized the following.

- 1) PVC 2 Core Cable with incoming service wire by pass of length 1.5ft (Approx)

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 3:50 PM on 03-02-2020. The accused person has committed an offence U/S135(1) (b) of the electricity act-2003 subsequently electricity (Amendment) act- 2007.
