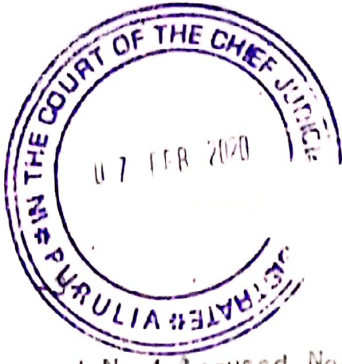
The humble petition on behalf of the  
above named complainant

Most respectfully sheweth:-

1... That the complainant is the legally married wife  
of Upendra Nath Mahato their marriage were solemnised  
on 17.6.2015. according to the Hindu rites and customs  
prevalent in their community in presence of some gentle-  
men of their locality. The marriage tie in between the  
complainant and accused no. 1 is still subsisting. The  
parents of the complainant's father gave ornaments, Gold  
and silver, utensils, sarees and others articles. Wrist  
watch, Hunda Shine Motor Cycle, cash money of Rs. 2,00,000/-  
(Rupees Two lakh) to the accused no. 1 at the time of  
marriage as per demand of the accused no. 1 to 4.

2... That after solemnisation of the marriage with the  
accused no. 1. the complainant went to her matrimonial house  
and began to lived there as husband and wife with the

with the accused No.1. Accused No.2 is the father, of ~~the~~ accused no.3, is the mother, ~~and~~ accused no.4 is the aunt of the accused no.1.

3...That after marriage the complainant and accused no.1 resided as husband and wife peacefully for about 2 years only. But after two years of the marriage when there was no issue, the complainant was subjected to mental and physical torture by the accused persons no.1 to 4. But the complainant as she is a good wife tolerated all the illtreatment some how and for that several time.

4...That however the torture upon the complainant continued unabated and she also subject to physical torture not only at the hands of her husband but also in the hands of accused no.2 to 4. She was not given due food and wears, she was assaulted by the accused no.1 to 4 all along without any occasions.

5...That during stay of the complainant in her matrimonial house the accused no.1 to 4 told the complainant to bring Rs.30,000/- and further Rs.15,000/- from her father. The father of the complainant give Rs.30,000/- to the accused persons as per their demand. The father & the mother of the complainant went to the house of the <sup>7</sup>With other witnesses and told the accused persons to keep the accused no.1 ~~with, and~~ complainant peacefully. But they

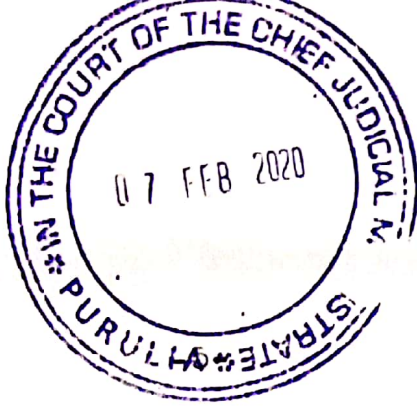

did not hear their good counselling and became very angry and rebuked them in filthy languages and the accused no.1 told loudly that he will marry another girl. The accused no.1 has illicit relation with another village girl.

6...That finally on the date of occurrence i.e. on 26.12.2019, corresponding to 9th day of Pous 1426 B.S. the accused persons no.1 to 4 assaulted the complainant with fist and blows, severely and some times accused no.1 and 4 pressed her neck in order to kill her. But somehow complainant was saved and subsequently accused persons drove away from their house to the complainant. Since then the complainant is living in her father's house.

7...That the accused persons nos.1 to 4 still threatening to kill the complainant and her father, mother and brother by different ways, that due to constant threatening, torture, illtreatment, harassment by the accused persons to father, mother and brothers and complainant the complainant became sicking nervous and failed on insequiye.

8..That the incident was reported to the local Pradhan and also to the police of Jhalda P.S. and thereafter to the S.P., Purulia and as per advice the

the complainant filed this case before your Honour .  
That all the accused persons no.1 to 4 are very dangerous  
and they have illtreated and tortured the complainant,  
Moreover they took Rs.30,000/- (Rupees Thirty thousand)  
further as dowry from the complainant after marriage.

In the circumstances, it is therefore  
prayed that your Honour will be kind enough  
to sent this complaint to the I/C Jhalda  
Police station threatening this petition as  
F. I. R. U/s 156(3) Cr.P.C.
