On 11.02.2020 at about 06.10 P.M. I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 01.Ganesh Mahato Gr1 TSH, Joypur CCC 02.Sristidhar Mahato, HG TSH, Joypur CCC, entered the premises of Miten Kalindi, S/O-Haralal Kalindi of village-Silphore, P.S- Joypur, Dist- Purulia and found Miten Kalindi, S/O-Haralal Kalindi was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSedCL through Cu cable yellow colour by means direct hooking to his house premises and connected load found 0.2 KW. As Miten Kalindi, S/O-Haralal Kalindi committed theft of electric power. The inspection team left the premises at 06.35 P.M.
