I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Sripati Kalindi, S/O-Chandi Kalindi of village-Silphore, P.S- Joypur, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 12.02.2020 at about 06.35 P.M. I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 01.Ganesh Mahato Gr1 TSH, Joypur CCC 02.Sristidhar Mahato, HG TSH, Joypur CCC, entered the premises of Sripati Kalindi, S/O-Chandi Kalindi of village-Silphore, P.S- Joypur, Dist- Purulia and found Sripati Kalindi, S/O-Chandi Kalindi was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSEDCL through plastic Cu cable white colour by means direct hooking to his house premises and connected load found 0.118 KW. As Sripati Kalindi, S/O-Chandi Kalindi committed theft of electric power. The inspection team left the premises at 07.00 P.M.
