In producing here with one arrested accd. namely Naru Gope {22yrs} S/O Manik Gope of Vill-Mayadh, PS- Joypur, Dist- Purulia along with following seized articles viz-

- 1) One plastic jarican containing 10 liters ID liquor
- 2) 25 pcs plastic Glasses

I ASI Joydev Garai of Baglata I/C under Joypur PS do here by lodged a complaint against accd. namely - Naru Gope (22yrs) S/O Manik Gope of Vill-Mayadh, PS- Joypur, Dist- Purulia to the effect that on 26.02.20 at about 07.45 hrs in course of my mobile duty he received a telephonic information from a reliable source that one Naru Gope S/O Manik Gope of Vill-Mayadh, was stocked of ID liquor illegally and selling the same to hike price for his personal gain then I informed O/C Baglata I/C under Joypur PS and as per his direction I ASI Joydev Garai of Baglata I/C along with force. At about 08.00 hrs he along with force reached Mayadh Village, and hold raid in the tea stall of him and found that Naru Gope S/O Manik Gope of Vill-Mayadh, PS- Joypur, Dist- Purulia, stocked ID liquor in a jarican at his own Counter/shop and seeing the police party some persons fled away and Naru Gope S/O Manik Gope of Vill-Mayadh concealed himself but I able to apprehend him and also detained him. So I seized 1) One plastic jarican containing 10 liters ID liquor, 2) 25 pcs plastic Glasses after preparing proper seizure list. So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd. person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accd. Naru Gope (22yrs) S/O Manik Gope of Vill-Mayadh, PS- Joypur, Dist- Purulia and arrange for its investigation.
