Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Santanu Chakraborty S/O- Bidhan Chakraborty, Vill+ PO-Rajra(Shibtola), Dist-PURULIA has committed theft of Electricity U/S-135(1)(a) of the Electricity Act 2003,(Amendment) Act-2007.

On dated 14.02.2020 I received a secret complain over telephone that Sri Santanu Chakraborty S/O- Bidhan Chakraborty, Vill+ PO-Rajra(Shibtola), Dist-PURULIA consuming electricity by means of direct hooking at nearest LT pole of WBSEDCL .

On the basis of said complaint at about 6.10 PM. I, Sri MrinalChowdhury, Divisional Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with, S&LP wing from RM Office, Purulia. And 1) Sri Dipak Kr. Bhowmik, SAE, Kashipur CCC

3) Sri Sanjoy Garain, OE, Kashipur CCC.

Entered the premises of Sri Santanu Chakraborty inspected his installation in presence of villagers . During inspection it has been found that he is consuming electricity dishonestly by means of direct hooking at nearest LT pole for poultry Farm though there is a permanent connection vide Meter No T02490626 . Total Load found approx 1.60 KW ( Pump-01 no, cfl-35 nos)

Then we disconnect his permanent connection and seized the following articles.

- 1) Hooking wire 50 Metre (approx) along with
- 2) Bulb with holder 01 nos

After preparation of proper seizure list the seizure list are prepared at the site and the representative of accused person refuse to sign in the seizer list. The inspection team left the above premises at about 6.40 PM. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

Due to break down of our line we could not submit the same on date.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
