Sub:-Prayer for starting a specific case against namely Madhu Majhi (42) S/O Lt Dasarath Majhi of vill Bakurdih, PS - Kashipur, Dist-Purulia

Sir,

In producing herewith one accused person namely Madhu Majhi (42) S/O Lt Dasarath Majhi of vill Bakurdih, PS - Kashipur, Dist-Purulia under arrest and the following seized articles under seizure list enclosed herewith:

- (1) Twenty one (21) sealed plastic bottles (CS) containing 600 ml each and labelled with DILKHUSH.
- (2) One light green nylon bag.
- (3) One big polythin chat.

I SI Prasanta Dutta of Kashipur PS do hereby lodge this complaint regarding that today (26.02.20) at about 19.45 hrs during my spl raid duty at Kashipur village received a source information over telephone that the above noted accused person has been selling CS liquor illegally and clandestinely at Bakurdih village in his house under Kashipur PS. On receiving the reliable source information I communicated with O/C Kashipur PS over telephone and as per his instruction I along with JC/1438 Tobarak Ansari, NVF/750 Krishna Singh Patar both of Kashipur PS rushed to the spot to work out the information. On arriving to the spot at 20.15 hrs I apprehended the above noted person after a strong attempt and one customer seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as noted above. I asked him to produce any valid paper in support of selling that liquor but he failed to produce any legal paper or document in support for selling such liquor. Accordingly at 20.25 hrs I seized all those noted above after preparing proper seizure and labelled the seized articles duly signed by the accompanying party and accused in the seizure list and the label. One bottle 600 ml liquor has been kept as sample taken from that seizure as sample which was also duly labelled and also took signature of the accompanying witness & accused on seizure list and label. After this I arrested that accused person namely Madhu Majhi (42) S/O Lt Dasarath Majhi of vill Bakurdih, PS - Kashipur, Dist-Purulia after preparing proper memo of arrest at 20.55 hrs.

Under the above facts & circumstances I pray before your honour that a specific case may kindly be started against the said accused person under proper section of law and arrange for investigation.
