Sir,

In producing here with one accused person Rathu Gorai (27yrs) S/O- Lt Gurupada Gorai of Vill- Narkoli, PS- Ranibandh, Dist- Bankura along with following seized articles viz-


- (1) 25 (Twenty Five) Ltrs ID liquor within a Jarikan
- (2) 13 pieces plastic glass
- (3) Sale proceed of Rs- 125/-

I S.I. Indrajit Sarkar of Manbazar PS do here by lodged a complaint against accused namely Rathu Gorai (27yrs) S/O- Lt Gurupada Gorai of Vill- Narkoli, PS- Ranibandh, Dist- Bankura to the effect that today (11.02.2020) at 16:05 hrs I received a telephonic information from a reliable source that one Rathu Gorai (27yrs) S/O- Lt Gurupada Gorai of Vill- Narkoli, PS- Ranibandh, Dist- Bankura was selling ID liquor illegally to hike price for his personal gain at road side near Swapan Subrata High School then I noted this information in GD vide Manbazar PS GDE No- 498 Dtd 11/02/2020 I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/1119 Sushanta Sinha and C/1429 Jagadish Ch Mahato rushed to the spot for raid by Govt. vehicle. At about 17:05 hrs myself along with force reached near Swapan Subrata High School and held raid where Rathu Gorai was selling ID Liquor illegally and found that rathu Gorai was selling ID liquor on roadside near Swapan Subrata High School and Seeing the police party some persons fled away and said Rathu Gorai tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly sign by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Rathu Gorai (27yrs) S/O- Lt Gurupada Gorai of Vill- Narkoli, PS- Ranibandh, Dist- Bankura as per law and arrange for its investigation.
