Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Purnendu Singh Bhumiz, S/O Rasu Singh Bhumiz of Village- Gosanipur (Pedda), P.O- Pedda, P.S.- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(b) of the Electricity (Amendment) Act-2007.

It is mention that service connection effected against Purnendu Singh Bhumiz, S/O Rasu Singh Bhumiz (having consumer ID -242159984, Meter No 731690)

On dated 14.02.2020 at about 01:30 PM I, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

- 1) Sri Mrityunjay Mandal, J.E. Gr.-I (E), Manbazar CCC
- 2) Sri Santu Dhali, J.E. Gr.-I (E), Manbazar CCC entered the premises of Purnendu Singh Bhumiz, S/O Rasu Singh Bhumiz of Village- Gosanipur (Pedda), P.O- Pedda, P.S.- Manbazar, Dist Purulia and inspected his/her premises and found that he was enjoying electricity un authorisely i.e bypassing of energy meter from incoming terminal point.

During inspection, theft of electricity was found, i.e., he was using electricity dishonestly U/S 135(1)(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and two piece of wire by which electrically directly flow to his house without energy registration in WBSEDCL energy meter. It was also found that he was using the following electrical equipments -

- 1) One no 40 Watt tube light
- 2) Three nos Fan 60 Watt each
- 3) Three nos 100 watt bulb
- 4) One no 60 Watt bulb
- 5) One no 100 TV

out of which we seized the following -

- 1) One no 60 Watt bulb
- 2) 1.5 Mtr PVC service cable

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 01:45 PM on dated 14.02.2020. The accused person has committed an offence U/S 135(1)(b) of the Electricity Act 2003, subsequently Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
