Sub: Request for providing police protection for stringing work in section 112/0 to 112A/0 of 765KV D/C Ranchi- Medinipur Transmission Line at village Rajgram, Jitujuri Gram Panchayat under TBCB project for strengthening of Eastern Region-II, ERSXVIII scheme.

Dear Sir,

During construction of 765 kV D/C Ranchi - Medinipur Transmission line, there was severe resistance of the land owners of village Rajgram under Jitujuri Gram Panchayat for construction work at location No. 112/1, 112/2 & 112/3 of the subject mentioned line. Finally the ROW was resolved and compensation was settled through a meeting between the land owners on 04.07.2019 in the Chamber of the SDO, Manbazar and work has been started on 05.07.2019. Tower foundation and erection activities at location No.-112/1, 112/2 & 112/3 has been completed in that area and the above section is ready for stringing.

This is to mention that 75% of work has been completed in that area and 75% of compensation towards foundation and erection work has already been paid in two instalments to the land owners and balance 25% will be paid after completion of balance 25% work.

This also to mention that on 29.12.2019, during shifting of Tools and Plants for stringing work at location no 112/3, some land owners have stopped our gang and forcefully taken the tractor's key, hacketed and threatened for dire consequence to our employee and forced them to depart from the site.

The matter was also intimated to the SDO, Manbazar also. The SDO, Manbazar tried to convince the land owners that the above Govt. work can not be stopp and requested them to co-operate with us so that the work can be completed and if there is any compensation issue to apply to the Judicial Magistrate for

settlement of compensation as per Indian Telegraph Act, 1885 through the meetings with land owners on 27.01.2020 and 04.02.2020 in his Chamber.

This is to inform that today i.e. on 05.02.2020 again we have started the stringing work in that section from location no. 112/1 and the following land owners has obstructed and forced to stop the work at 2:15 PM.

We have requested a lot to continue the work but they didn't allow. Presently the work cannot be started without police protection.

They are obstructing this Central Govt. Project involving power transfer to the Govt. of WestBengal. Government will loss a lots of revenue due to delay in commissioning of the project. The State Government Ministry & officials are also pressing hard on us for early completion of the project and we are unable to complete the job due to rigidness of the landowners.
