I do hereby lodge complaint empowered by enabling the IE Act 2003 subsequently (amendment at 2007) to the effect that today (06/02/2020) at about 14:30 hrs he was enjoying electricity unauthorisedly i.e. by passing the energy meter and due to this reason he

has committed theft of electricity u/s 135 (1)(b) of the electricity act 2003 duly amended on 2007 in spite of having a authorized connection against consumer id. 242053931
