Sub: Prayer for starting a specific case under proper section of law.

Sir,

In producing herewith seized vehicle (407) bearing no – WB 67A/1080 loaded with raw coal of 05 M.T. (approx) and vehicle (407) bearing registration No- WB 11A/8736 loaded with raw coal of 04 M.T. (approx) do hereby lodge a complaint to the effect that on (15/02/2020) myself along with C/1140 Dayamoy Mahato and C/470 Somnath Nag all of Neturia PS were engaged in Naka duty at Haridih More vide Neturia PS GDE No- 666 Dt. 15.02.2020 & CC No- 368/19 Dt. 15.02.2020. In course of Naka duty at about 19:05 hrs received a credible source information that two vehicles (407) bearing no – WB 67A/1080 and WB 11A/8736 loaded with illegal coal coming from Raghunathpur side and will transport the same to Asansol side through Purulia – Barakar road in clandestine manner as per their regular practice. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force remain alert there to intercept the vehicles. During naka checking we found that two vehicles were coming from Raghunathpur side, suddenly both the vehicles stopped about 90/100 meter away from us and one person from each vehicle seems to be the driver of the vehicle got down from the vehicles and started running towards dark side beside the road. We chased the persons but in spite of hot chase they managed to flee away. We searched the surrounding area with torch light to find out the persons but failed to trace out them. On search we found that the vehicle (407) bearing no – WB 67A/1080 loaded with raw coal of 05 M.T. (approx) and vehicle (407) bearing registration No- WB 11A/8736 loaded with raw coal of 04 M.T. (approx) and the key of the vehicles has been left away in the vehicle by the drivers.

So, there is reason to believe that the driver, owner of coal and registered owner of the both vehicles have collected the said coal either by theft or by any fraudulent means and after hatching a criminal conspiracy, they are trying to dispose of the same coal in a clandestine manner to Asansol side knowing it to be stolen, as per their regular practice.

Accordingly I seized the vehicle (407) bearing no – WB 67A/1080 loaded with raw coal of 05 M.T. (approx) and vehicle (407) bearing registration No- WB 11A/8736 loaded with raw coal of 04 M.T. (approx) under proper seizure list duly signed by the Police witnesses in between 20:05 hrs and 20:25 hrs, since no public witness was found.

Under the above circumstances a specific case may kindly be started against the (1) driver of vehicles No- WB 67A/1080 and WB 11A/8736 (2) owner of the coal, seized from vehicles No- WB 67A/1080 and WB 11A/8736 and (3) Registered owner of vehicles No- WB 67A/1080 and WB 11A/8736 under proper section of law.
