FACT OF THE CASE:-


The above name complainant most respectfully begs to submit:-

1. That Priti Bouri(victim girl) is my daughter, as aged about 16/17 yrs. old student of saltore colliery High school taking preparation of Madhyamik. She is minor. She is not acquinted with the wordly affairs, well and she has not attended the age of majority, So, unable to take any decission regarding herself without the consent of her parents.

2. That on 27-11-19 at about 4=30 A.M. said Priti Bouri D/O Sanjoy Bouri and D/O Jyotsna Bouri went to a vacant place behind the house of the complainant as the complainant has got no bathroom or latrine attach to his dwelling house in order to response natural call. She took a hand tourch light along with her. But after laps of one hour when she didn't came back her mother. Jyotsna Bouri point out the matter to the complainant and that complainant then anotheir make a through search sourrounding village Saltore to find out said Priti Bouri but he cound not find out his daughter, inspite out thorough searh to hours. The complainant inform the matter to his relatives and different places but he could not trece out his daughter.

3. That ultimately the complainant went to Neturia P.S. and inform the officer-on-Duty namely Md. Mansoor Alam. But Mansoor Alam did not take in a inisitive to receive the complain of the complainant rather he told the complainant his daughter would arive in the police station within few minutes. In the mean time the father of Jitendra Maddi is Sunil Maddi came into police Station alongwith his wife Rosi Maddi, following them said Jitendra Maddi and daughter of the complainant Kumari Priti Bouri entire in the P.S. All of they disclosed that they had been in the house of Sunil Maddi and Rosi Maddi till their arrival of P.S.

4. That after arriving into the P.S. said Jitendra Maddi, Sunil Maddi and Jyotsna Maddi asked the police officer to said them free as said Jitendra Maddi would marry minor daughter of the complainant i.e. Priti Bouri having heard this the complainant made strong protest against such statement made by Jitendra Maddi, Sunil Maddi and Rosi Maddi.

5. That the complainant repeatedly requested on police officer on duty Md. Mansoor Alam to handover Priti Bouri under the custody of complainant and start a specific case against the accd. persons. But astonisingly the officer-in-duty Md. Mansoor Alam told the complainant that complainant should not be strickt on his proposal as he has already talk to Jitendre Maddi and K mari Priti Maddi and they/agreed to marry each other and to stay together in the house of Sunil Maddi at vill Arjun Dhawra, PO:-Saltore, PS:-Neturia, Dist: Purulia under a common roof as husband and wife.

6. That the complainant requested the police office time an again that his daughter Kumari Priti Bouri so, she cann't give her valid consent to marry any one. But police officer with anger told the complainant that he has confirm that said

Kumari Priti Bouri attended the age of majority and ultimately said police officer Md. Mansoor Alam allowed Jitendra Maddi his father Sunil Maddi and his mother Rosi Maddi to take Kumari Priti Bouri alongwith them for the purpose of preparation of marriage with isillegal and forcible too. The acts of the accd.person and tentamounts to abduction on a woman(V.G.) to compelled her marry the accd.-1 & prosecution of a minor girl. 7. That the complainant went to F. S. Neturia repeatedly to do something to recover her daughter from the custody of accd. person but said police officer refused to do anything against accd. person at everytime.

8. That the complainant ultimately send a complain to S.D.P.O Raghunathpur and S.P. Purulia by register post with A/D. But till today no action of police has been taken till today to recover Kumari Priti Bouri the minor daughter of the complt.

9. That the matter of very urgent so, the complainant file the present case against the accd. persons. 10. That be it noted that the complt. have lodge no complain against the accd. person in respect of the offence committed by the accd. personbefore any court or any forum other than the document which the petitioner has It is therefore prayed the necessary case to be started against the accd. persons, treating the complain as F.I.R. with a specific direction to the O.C- Neturia to recover Kumari Priti Bouri from the custody of accd. persons wher ever they are traving living.
